Business Manager - Louisa Legato:

- Introduced Auditor, Samara Johnson from Lanter, Leonardo & DiCrescenzo, LLC.
- > Samara reviewed the audit findings and answered questions. No findings, clean opinion and no obstacles reported and commented the school is in a good financial position.
- > Russ Feldman made a motion to approve the 2020-2021 audit report, Steve Carroll seconded the motion and all board members voted in favor.
- ➤ It was stated to re-hire the audit firm, Lanter, Leonardo & DiCrescenzo for the 2021-2022 Audit. A motion was made by Steve Carroll, Russ Feldman seconded the motion and all board members voted in favor.

Executive Directors Report - Ann Eisenberg:

- > It was stated there were two outside guests attending the board meeting.
- > It was stated there was another guest, attorney Melissa Arnold, in attendance for an update on the property purchase.
- > It was stated by Melissa there would be a commitment letter coming soon for signature. As well as a draft of the loan documents, which a special board meeting would need to be scheduled to approve prior to the closing in November.
- > It was stated we are continuing to meet with families for enrollment, but we are full for most programs and will add to the waiting list.
- > It was stated our Family Services Director, Adriene Fern, has been hosting Zoom workshops to help families feel supported.
- > It was stated President, Randee Gabriel, has joined the meeting and the meeting was turned over to her.
- > It was stated talks continue about getting a school zone in front of the school. One of our parents contacted the local commissioners, which re-ignited the talks.

Associate Director - Allison Ballin

- > It was stated a lot of Intakes were being done for K-2, mostly from the District and families from out of state as well as PBSFA families recommend others to us.
- > It was stated we are using additional curriculums: WebAbles; and AFLS to make sure everyone has what they need. Both programs collaborate with therapists and teachers.
- > It was stated all staff continue to receive and will continue on-going additional training through-out the school year.
