Board of Directors Approvals:

➤ Board members reviewed the minutes from the May 6, 2024 Board Meeting. Steve Carroll made a motion to approve the minutes and Jerry Zel seconded and all board members voted in favor.

<u>Business Manager - Louisa Legato:</u>

- It was stated the position of the financial statements and bank account balances.
- > Louisa shared the Profit and Loss Statement for July 2024
- ➤ Louisa stated the School District needs us to vote to continue using Building Hopes services for day to day accounting services.
